To build a network of middle to top managerial bankers in Indonesia

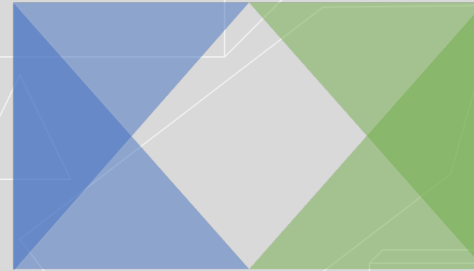
There are a lot of room for improvement in the transaction banking area, both regulation and best practice in the industry

## What

Task Force team is a group of individuals (**not representing the company he/she is currently work with**) as a professional in transaction banking industry who will contribute to the establishment of professional testing by GTBS

## Why

To push the professional testing quality **up to the industry standard** and reflecting from **local and global best practice** of transaction banking

## Purpose

To help in designing the **scope, depth & length** of both professional testing of GTBS (Verified Professional Trade Finance & Verified Professional Cash Management)



## How

Task force will be divided into **two team** :

1. **Trade Finance** for Trade services, trade finance, guarantee, SCF & digital banking scope
2. **Cash Management** for payment, cash management & digital banking

Each team and individuals **will/may contribute** the following :

- a. The scope, depth & length of professional testing
- b. Up to 20 item of question or more (may consisted of multiple choice, true or false, case studies)

## When

Task force team will have a period of **2 months** from 14 April to 14 June 2023 to conclude the scope and submit the question which then will be mixed in the final question for the professional testing
